#### D.- Other provisions:

- The above Scale shall be applied taking into consideration the amounts claimed in each arbitration, or the economic interest thereof, which shall be fixed by the Court.
- The administration fee and fees for the claim and counterclaim shall be calculated separately.
- Arbitrations of an initially undetermined amount shall be calculated on the basis of €50,000, without prejudice to their subsequent determination.
- Where the arbitration is international, at the discretion of the Court, and taking into account the applicable rules, the maximum fee and fee schedule may be increased by up to 20% at the discretion of the Court.
- The application of the maximum and minimum scales for arbitrators shall be at the discretion of the Court.
- In the event that there are three arbitrators, the total fees of the arbitrators shall be the result of multiplying the above Scale by three.
- If there are three arbitrators, the distribution of the total arbitrators' fees among them shall be as follows: 40% Chair and 30% each remaining arbitrator. Due to the specific circumstances of the arbitration, the Court, if it deems it appropriate, may determine that the percentage corresponding to the Chairman be higher, in which case it may raise it to a maximum of 50% of the total fees of the arbitrators.
- Where the proceedings continue for more than one year after the appointment of the arbitrators, the Court may make payments on account of fees to the arbitrators, up to the minimum amount that would be due to them in the event of prompt termination at that time.
- 2,000 for each arbitrator appointed (plus VAT, if applicable).
- In arbitration proceedings in which an application is made to challenge the award, the arbitrators' fees shall be 50% of those provided for in the proceedings in which the award under review was made.
- The above fees and dues do not include any expenses that may be incurred by the arbitrators, which shall be passed on to the parties upon justification by the arbitrators and upon approval by the Court of all or part of the same.
- This Annex shall apply to arbitrations commenced on or after 01 September 2020.
